The appointee (s) shall report to the HoD (Labour Commissioner J&K/Director Employment J&K) of the concerned office allotted to them, within a period of 21 days from the issuance of this order and shall be allowed to join only on production of the following documents/certificate in original, to be verified subsequently:-

- a. Academic Qualification Certificate.
- b. Date of Birth Certificate.
- c. Health Certificate issued by Chief Medical Officer of the District.
- d. Domicile Certificate issued by the Competent Authority.
- e. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under Self Employment Scheme has been taken by the appointee.
- f. Reserved Category Certificate (in case of candidates belonging to reserved category).

The appointment of each candidate mentioned in the Annexure shall further be subject to the following conditions:-

The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in

the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of the appointment without any further notice.

ii. Each appointee shall furnish an Undertaking in the shape of an

Affidavit as per Annexure-B to this Order.

iii. The salary of the appointees shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedent Report is received from the concerned Authority/Agency.

iv. The appointees shall be on probation for a period of two years.

v. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.

- vi. The inter se seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 in the respective departments allotted to them as per the selection list of Services Selection Board.
- vii. The Cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any Authority/Department
- viii. The appointment shall be cancelled ab-initio, if it is found at any stage that the appointees possess higher qualification than the prescribed one and he/she shall also be liable for criminal prosecution under law.

ix. The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
