Accordingly, the Lieutenant Governor hereby dismisses Samiem Ahmad Bazaz, Supervisor (office of Deputy Labour Commissioner, Kashmir) S/o Mohammad Ashraf Bazaz, R/o Umar Hair, Buchpora, Srinagar from service, with immediate effect.
