Terms of Reference:-

- i. To review the functioning of Labour Department and also examine best practices adopted by the other states/UT's.
- ii. To review the department's performance in implementing labour policies and programs aimed at protecting workers' rights, ensuring workplace safety, and promoting fair labor practices.
- iii. To examine the department's mechanisms for enforcing labor laws, investigating complaints, and resolving disputes between employers and employees.

- lv. To furnish the comprehensive report alongwith suggestions/ recommendations to remove existing bottlenecks.
- v. To review the disposal of cases pending before different Quasi Judicial authorities of Labour Department in J&K and mechanism for timely disposal of Labour Cases.
- vi. To advise on conflict management resolution and family-friendly employment practices for the purpose of fostering harmonious employer -employee relations.
- vil. To advise on all the issues pertaining to HR matters of employees of Labour Department, including career management and progression.
- vill. To submit a comprehensive report on, how to carry out extensive Information, Education & Communication (IEC) activities for dissemination of Labour welfare provisions to the targeted groups.
- ix. To bring into the notice of the competent authority about defects or abuses not specifically covered under existing provisions.
- x. To devise a mechanism for 100% coverage of insurance for all workers and saturation of PMJJBY, PMSBY, PMSYMY & SEHAT SCHEME.
- xi. To devise a mechanism for implementation of minimum wages act and methodology for timely updation of minimum wages.
- xii. To submit a comprehensive report about compliance of child labour Act and Bonded Labour Abolition Act.
- xiii. To devise a mechanism for 100% availability of ration card to the workers registered on eShram portal and IEC campaign for awareness among workers to avail benefits of registration on eShram portal.
- xiv. To submit a report regarding up skilling of labourers as per market requirement.
- xv. To submit a proposal along with DPR for establishment of Tertiary Care Health Facilities under ESIS.
- xvi. To devise a mechanism for central automated Inspection System.Any other suggestion / recommendation by the Committee.

The aforementioned committee shall submit its report by or before 5: 30 P.M. of 10th May, 2024, positively.
