- vi) To submit a comprehensive report on, how to carry out extensive Information, Education & Communication (IEC) activities for dissemination of Employment Schemes run by the Government to the targeted groups.
- vii) To submit a report on roadmap for generation of 01 lac Employment through entrepreneurship.
- viii) To submit a report on establishment of District Youth Center as a one stop solution for unemployed youths in all the Districts.
- ix) To submit a comprehensive job fair calendar and prepare a database of local employer along with their requirements for job vacancy.
- x) To submit a comprehensive District specific employment plan.
